**Please read carefully the following information and instructions BEFORE sending the Media Accreditation request**

**THIS DOCUMENT HAS TO BE SIGNED (MANDATORY)  
BY THE MEDIA PASS-HOLDER TO GET HIS MEDIA CREDENTIAL.**

**PLEASE NOTE:**

. For the 2022 Circuit des Remparts and all the associated Exhibitions (and the preparation thereof) the Organizers state that only Photographers, Cameramen, Sound Recordists and Journalists who are holders of a French Professional CCIJP, AFPA, UJSF Card or an equivalent Foreign Professional Card can gain the « MEDIA 2022 » accreditation.

. Particular cases, who do not meet these criteria, can be examined;

. The Organisers reserve the right to accept, or refuse to grant Media Accreditation.

. **IMPORTANT:** according to the sanitary condition during the period of The Event, the Organizers retain the right to immediately take appropriate measures.

**THE ACCREDITED PERSONS AGREE UNDER ALL CIRCUMSTANCES:**

**BEFORE AND ABOVE ALL: to strictly follow the sanitary instructions, and do her/his maximum to protect her/himself and the others;**

**I.** to be vigilant in the manner which suits a Motorsport event;

**II.** to respect and adhere to all Laws and Rules, but in particular the Traffic Laws;

**III.** to respect and adhere to all instructions given by any member of the Security Staff, Enforcement Staff, the Organizers and their Representatives, namely the Stewards and Marshals, and the Events Press Officer and Staff;

**IV.** to show understanding and be courteous and respectful to all members of the Public, Participants, Sponsors and the Organizers, and of course members of the Security Staff and Enforcement Staff;

**V.** to carry all their Accreditations, ID numbers and identifying clothing (including their Media Tabard) in a manner visible to all;

**VI.** to not enter any Prohibited Zones which are marked, or indicated by Staff.

**Failure to follow these instructions may lead to the withdrawal of Media Accreditation.**
